International Programme Review

International Programme Accreditation (IPA) enables non-UK higher education institutions to demonstrate that their approach to programme design, development and monitoring are effective and comparable to international best practice, supporting curriculum development and student achievement.

Through an independent peer review by QAA, IPA assesses the standards and quality of individual programmes of study against the European Standards and Guidelines for Quality Assurance in the European Higher Education Area (ESG).

The review includes the systematic monitoring and evaluation of learning and teaching, and the processes that support them. This is combined with specific review of individual programmes of study. This makes sure that the standards of academic awards meet the required level and the quality of the student learning experience is being safeguarded and continually improved.

QAA International Membership

International Membership provides vision, expertise and guidance on the topics that matter to your staff and students. There are two tiers of International Membership:

Full International Membership

- available to all institutions that have QAA's International Quality Review (IQR) accreditation.



International Associate Membership

- available to institutions that do not yet have QAA's IQR accreditation but are recognised by their local quality agency.



International Membership provides access to a range of exclusive quality enhancement resources, designed to support institutions in improving their own provision. These are available to all staff and students at member institutions, through QAA's Membership Resources site. International Members also have access to exclusive events, workshops, briefings and training that outline developments and best practice in all aspects of international quality assurance.

International Quality Assurance Programme

The International Quality Assurance Programme (IQAP) is a five-day training course for international delegates by the UK's Quality Assurance Agency for Higher Education (QAA). IQAP enables attendees to:

- learn from experts in UK and international quality assurance
- learn from other colleagues from around the world working in similar roles
- reflect on different roles and practices
- develop skills and identify areas for further development.

IQAP also includes visits to UK universities and institutions to see examples of higher education quality in action.

By the end of IQAP attendees will:

- have learned new skills that can be used when planning the improvement of quality assurance within their organisations
- be able to comment more effectively on issues facing quality assurance in education globally
- have gained knowledge and experiences from colleagues working in other countries.
