Case study: Developing a transnational education quality framework in Kazakhstan

In November 2024, QAA was commissioned by the British Council in Kazakhstan to develop a transnational education (TNE) quality framework. The aim was to support the efforts of the Ministry of Science and Higher Education to establish clear delivery standards and ensure a high quality experience for domestic and international students in a flourishing TNE landscape.

QAA conducted a review of the existing environment for transnational programmes and drew on our experience as custodian of the UK's quality reference points to propose a TNE quality framework tailored to the

specific context of Kazakhstan. The framework provides governing quality principles for existing and new TNE partnerships and an action plan for implementation.

QAA was proud to collaborate with many valued partners and stakeholders to achieve the objectives of this high impact initiative. Crucial contributions were provided by 25 local experts from Kazakhstani universities, leadership from UK institutions delivering programmes in Kazakhstan and seminar audiences made up of the broader Kazakhstani higher education community.

Establishing a robust QA framework

Case study: Enhancing Quality Assurance and Accreditation in Viet Nam Higher Education for International Integration

From 2023 to 2025, QAA provided technical support towards delivery of the 'Enhancing Quality Assurance and Accreditation in Viet Nam Higher Education for International Integration' workplan, a partnership between the British Council and the Viet Nam Education Quality Management Agency (VQA), part of the Ministry of Education and Training. The workplan aims to enhance and add an international dimension to quality assurance and accreditation standards across the Vietnamese higher education sector.

During delivery of this project, a team of QAA experts collaborated with the British Council and VQA to:

 conduct a comparative review of the quality assurance system in Viet Nam through benchmarking and mapping to the quality assurance system in the UK

- deliver technical training and review the development of standards and guidelines for domestic and international quality assurance in Viet Nam
- meet periodically with Vietnamese partners to exchange updates and seek additional input and guidance to ensure success
- facilitate stakeholder workshops and produce a series of project outputs
- support capacity building at selected Vietnamese universities as they continue to develop effective internal quality assurance systems.

Case study: Enhancing Quality Assurance and Accreditation in Viet Nam Higher Education for International Integration

Hanoi University of Science and Technology has been implementing major projects as we conclude the strategic development period from 2017 to 2025 and begin a new strategic plan for the period from 2025 to 2035, with a vision extending to 2045. This project has reinforced our internal quality assurance, fostered a culture of quality in line with international standards, and enhanced our global standing. The gap analysis will help us develop a quality improvement roadmap that aligns with our current context and future development plans aimed at achieving QAA accreditation.

Case study: Strategic support for the Higher Education Commission, Pakistan

In 2022-23, QAA partnered with the British Council and the Higher Education Commission (HEC) in Pakistan on a strategic initiative to strengthen collaboration between the higher education sectors of the UK and Pakistan. This project aimed to establish a new national QA framework for assessing the quality of higher education institutions and programmes in Pakistan, fostering a more outcome-driven and results-oriented approach.

Key achievements

Review of QA procedures

We conducted a comprehensive evaluation of existing QA processes in Pakistan and provided recommendations to improve their efficacy and alignment to international best practice.



Case study: Strategic support for the Higher Education Commission, Pakistan

Development of practical QA resources

The project led to the creation of a suite of new resources, including:

- a quality code to provide a structured approach to academic standards
- a quality assurance manual to guide institutions in implementing QA processes
- a mechanism for academic audit to strengthen oversight at programme and institutional levels.

Contextualised QA framework

In collaboration with the HEC and higher education institutions across Pakistan, we ensured all outputs were tailored to the local higher education and QA environments.

Workshops and capacity building

Alongside the HEC, QAA delivered training workshops for senior leadership, faculty and students in Pakistan's higher education institutions. Based on stakeholder feedback, the project emphasised a student-centred and outcome-focused QA approach, shifting from a compliance-based to an enhancement-focused model.



Case study: Strategic support for the Higher Education Commission, Pakistan

New QA framework for Pakistan

The proposed framework became the principal tool for higher education quality assurance in Pakistan, informing Precepts, Standards and Guidelines for Quality Assurance in Higher Education and three interconnected review processes:

- 1. Evaluating the effectiveness of QA and accreditation bodies
- 2. External QA at programme and institutional levels
- 3. Internal QA at programme and institutional levels.

Training and evaluation

Following development of the QA framework, QAA provided training to the HEC and higher education institutions to ensure effective implementation. In the next phase of the project, QAA will support the HEC's pilot exercise to evaluate the strength, value and efficiency of the new QA framework.

Through this collaboration, QAA played a key role in advancing Pakistan's QA landscape, strengthening international partnerships between the UK and Pakistan, and enhancing long-term capacity building in higher education.
